# Administrative Update

2011 SPRING QUARTERLY MEETING

## SWAN's Role in Act 101

Act 101 is effective April 25, 2011. This act is three-fold, creating: 1) the option to enter into a voluntary post-adoption agreement, 2) an expanded registry that includes both medical and social history information and 3) a policy on how to respond to requests for information related to adoption.

The prime contract for the Statewide Adoption and Permanency Network, SWAN, which currently has responsibility for maintaining the Adoption Medical History Registry, AMHR, will begin assuming responsibility for the new Pennsylvania Adoption Information Registry, PAIR, on the date the new act becomes effective.

While the PAIR will continue to collect much the same medical information that the AMHR collected, the new registry will also

collect much more. Adoptees and birth families will be able to register medical, social, educational and cultural information and request contact with their birth relative.

This is an exciting new time and opportunity for adoptees and birth family members. The SWAN prime contract will keep you informed about the registry, including how you will submit or request information from it, as the act is implemented. Stay tuned for more details about how the registry is going to work. We will continue to keep you informed about related trainings and information about the PAIR and how you and the children and families you serve can get the most from it.

## We Will Come to You

Does your county use SWAN's Pennsylvania Adoption Exchange, PAE? Do you know who your coordinator is? PAE has three coordinators: Jennifer Casner-Hockenberry, southeast and west; Denise Maxwell-Howell, central; and Karen Lollo, south central counties. The coordinators are available to train both county and affiliate staff on using PAE's services and recruitment strategies for locating permanent resources for children.

Since the beginning of this year, the coordinators have traveled around the

state sharing the best ways to use PAE's services to meet the needs of children.

Whether you have new or seasoned staff, a coordinator will be glad to come to your county to speak about how PAE can assist in finding permanency for children. A list of the county assignments for each coordinator is in your quarterly packet. You may also ask your regional TA for the contact information and make the connection for you.
