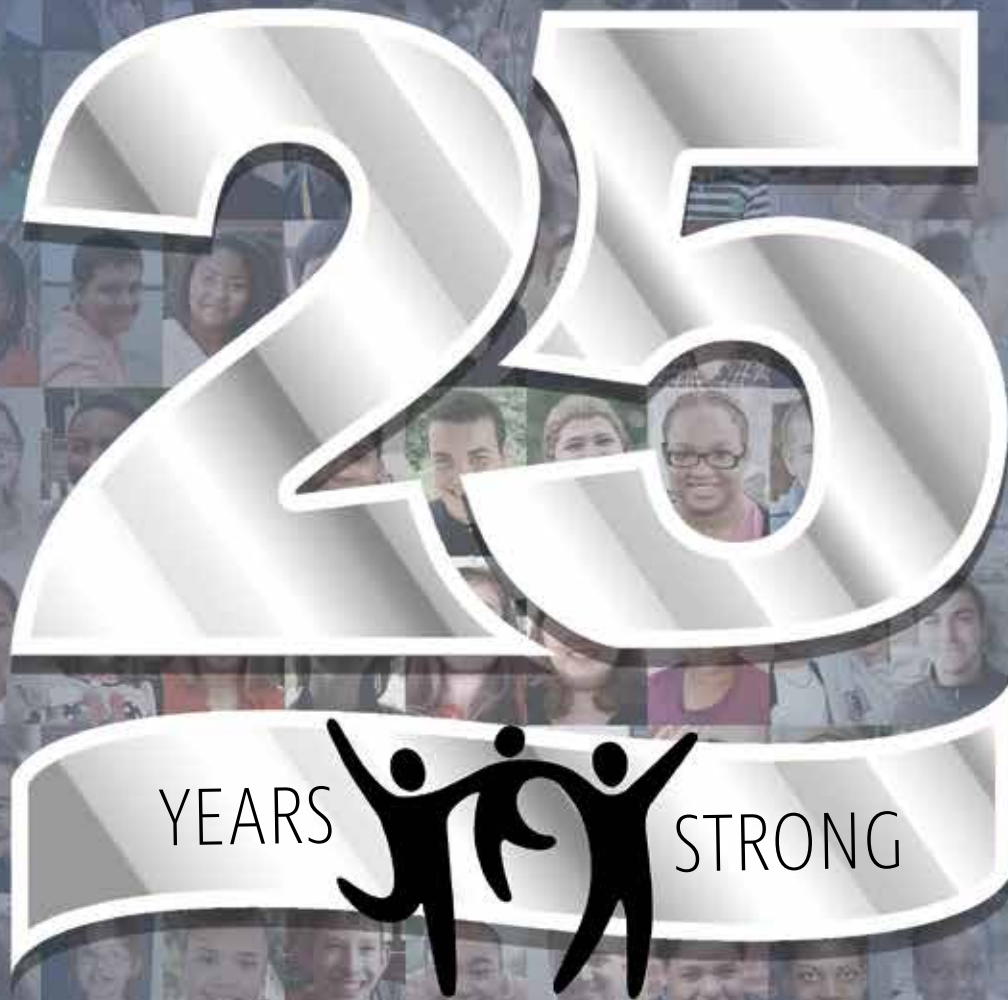

## General Information



### Purpose

The 25th Annual Pennsylvania Permanency Conference, **25 Years Strong**, focuses on ways families and professionals from all aspects of the child welfare system can support one another and work together to achieve permanent connections for all children and youth.

The conference serves as a forum to train participants who will prepare children and families for their journey through the child welfare system towards permanency. The conference is designed to educate and support current and prospective foster and adoptive families, kinship care providers, permanent legal custodians, attorneys, child welfare professionals and others with a vested interest in permanency for children. The conference is a focal point for networking and sharing information to increase the knowledge base on the issues for children and youth in special needs adoptions and permanency.

### Audience

The conference is designed for current and prospective foster and adoptive families as well as families providing other permanency options such as kinship care or permanent legal custodianship, attorneys, mental health professionals, independent living professionals, public and private agency professionals and the children on behalf of whom they work.

## Constance Krebs Iannetta

Constance Iannetta (née Krebs) spent six years in the dependency system before aging out at eighteen years old.

An active advocate on child welfare and mental health issues for more than 10 years, Constance has provided testimony for foster care legislation. She co-founded the Pennsylvania Chapter of Foster Care Alumni of America (FCAA), is a founding member of the Bucks County Youth Advisory Board, has served on the Philadelphia Blue Ribbon Commission on Children's Behavioral Health, and is a youth partner for Montgomery County's Bridges Systems of Care Leadership Team. Her work has been recognized with awards from the Montgomery County Board of Commissioners, the Golden Heart Group and the Pennsylvania Statewide Adoption and Permanency Network (SWAN).



Constance attended The Restaurant School at Walnut Hill College prior to earning a business degree from Gwynedd Mercy University. She currently works full-time at a foster care agency in the Philadelphia area and is a national director for FCAA, focusing on the nationwide FosterWalks fundraising and awareness campaign and the FCAA Scholars program. She resides in Montgomery County with her husband and kinship children.

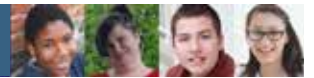
### Family Fun Night

## Conference Closing



### Connie Going

Connie Going is a national adoption advocate and CEO of the Adoption Advocacy Center. In her more than 25 years as a child welfare and adoption specialist, she has worked in prevention and reunification and actively facilitated more than 1,000 adoptions.

In 2012, the Congressional Coalition on Adoption Institute recognized Connie with its National Angels in Adoption® award for her outstanding advocacy efforts. She also received the Irene Sullivan Adoption Advocacy Award in 2014 and the first ever Let It Be Us Adoption Advocate of the Year Award in 2015. In 2016, she received a Tampa Bay Lightning Community Hero award and was deemed a Bay News 9 Everyday Hero.

Connie is certified as an adoption expert and an adoption speaker, trainer and educator. In 2013, she brought 15-year-old Davion to a church to speak about his desire to be adopted. The story of his search for a forever family garnered international attention, and the following influx of families interested in adoption became known as “the Davion Effect.” This innovative recruitment experience

resulted in development of an Inquiry/Match system that ensures every inquiry for a child receives a timely response and holds the systems of care accountable for every child available for adoption.

Connie continues to create awareness through her weekly internet radio show, *Like It Is*, which highlights transparency in the child welfare system. She has appeared on *Daytime*, *The View*, *ABC World News With Diane Sawyer*, and *CBS Evening News On the Road With Steve Hartman*, and in *Woman’s World*, *PEOPLE Magazine*, *The Huffington Post*, and *Newsweek*.

Not only is Connie a professional in child welfare, but she is an adoptive parent herself. In addition to two biological daughters, Connie, a single parent, also adopted two teenage boys who grew up in foster care: Taylor, whom she watched languish and bounce through foster care when his previous adoptive parents returned him, and most recently Davion, the young boy whose story raised awareness on the need for adoptive parents. As a parent to four young adults, Connie is even more passionate about finding solutions that support and make a difference in the lives of children of trauma and their families. She truly believes that everyone can make an impact.

# Child/Teen Care Program Information



## Child Care and Teen Registration

We are pleased to provide on-site child care, as well as activities for older children. Additional forms and payments are required if you are requesting child care. A Child/Teen Care Registration Form (included below) must be completed for EACH child and teen who is participating in the sponsored activities. **Child/teen care is offered on a first-come basis. The deadline for child/teen care registration is May 12, 2017.** All child/teen care registrations received before May 12, 2017 will receive an informational confirmation packet.
